Who should I give consent to?

OPTION 1

My Support Coordinator and employees of their company

This means we can share your information with your Support Coordinator <u>and</u> other employees of their organisation. This is a good option for certain circumstances and helps reduce paperwork in future, such as when your Support Coordinator is not available to deal with an enquiry (e.g. they are sick or away on leave).

OPTION 2 My Support Coordinator only

This will mean that we can share your information with your Support Coordinator only.

Only your individual Support Coordinator can access your personal or plan information. If they are not available to deal with an enquiry, then there may be a delay in processing an invoice or resolving an issue.
